### WHAT DOES AB INITIO FINANCIAL LLC DO WITH YOUR PERSONAL INFORMATION?

#### Why?

Financial companies choose how they share your personal information. Federal law gives consumers (our clients and prospective clients) the right to limit some but not all sharing. Federal law requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

The firm collects personal information about consumers from the following sources:

- ✓ information provided to us for their financial plan or investment recommendations
- ✓ information provided through engagement agreements and other documents completed in connection with the engagement
- √ information provided verbally, and
- ✓ information received from service providers, such as custodians, about investment account transactions.

#### How?

Financial companies often need to share consumers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their consumers' personal information, the reasons Ab Initio Financial LLC chooses to share, and whether you can limit this sharing.

Why can't I limit all sharing?	Federal law gives you the right to limit only  sharing for affiliates' everyday business purposes  affiliates from using your information to market to you  sharing for non-affiliates to market to you  State laws and individual companies (i.e., your insurance company, etc.) may give you additional rights to limit sharing.

Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies.  ✓ Ab Initio Financial LLC does not have an affiliate.
Non-Affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies.  ✓ Ab Initio Financial LLC does not share with non-affiliates.
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  Ver do not engage in joint marketing arrangements.
